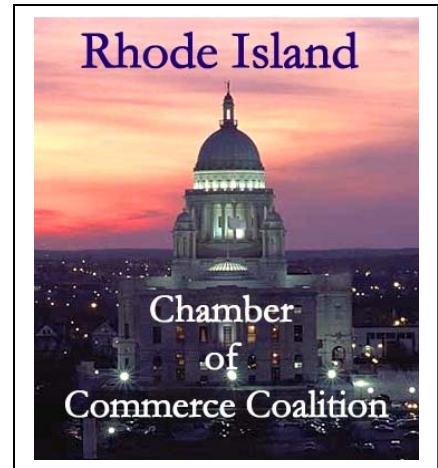

Bills of interest and Chamber Coalition positions

This act would provide that a health benefit plan issued to a small employer with an aggregate number of at least 100 insured individuals is exempt from the provisions of the small employer Health Insurance Availability Act. **Chamber Coalition supports**

This act would ensure that businesses employ fair policies relating to the screening and identification of persons with criminal backgrounds through the BCI system. **Chamber Coalition opposes**

This act would prohibit an employer from refusing to hire a person based solely on the existence of a criminal record, with some exceptions, or for a governmental agency from denying an individual a license to work in a particular trade or business based solely on that individual having a criminal record, with certain exceptions. **Chamber Coalition opposes**

This act would provide that the issuance of a physical alteration permit shall be required for the issuance of a building permit, however the lack of a physical alteration permit shall not delay an examination by a building official. This act would further provide that the director of the department of transportation shall respond to the permit application within thirty business days, and the deadline may be extended due to unusual circumstances or complex projects. **Chamber Coalition supports**

This act would shorten, from 60 to 30 days, the amount of time a building official can reject or accept an application for a building permit. It would also establish provisions for permit applications for commercial buildings. **Chamber Coalition supports**

This act would require that plan review fees collected by the state fire marshal's office be placed in a restricted receipt account to retain the services of professionals to assist in the plan review process and would support the training and education requirements of the marshal's office. The balance of the fees would be deposited as general revenue. **Chamber Coalition opposes**

This act would impose a sales and use tax with respect to the sale and to the storage, use, or other consumption in this state of any new or used boat. All sums received by the division of taxation under this section as taxes would be distributed by the state treasurer to each city or town in proportion to their population. **Chamber Coalition opposes**

This act would increase the estate tax exemption from \$850,000 to \$1,500,000 for deaths occurring after January 1, 2013. **Chamber Coalition supports**

This act would require all Rhode Island corporations to opt out of the domestic production deduction, to add back any amount to their income they would deduct under this deduction. **Chamber Coalition opposes**

This act would require recipients of certain tax credits to annually file reports with the state tax administrator. The reports would contain employment information for all of their employees. This act would change the definition of a retailer for sales and use tax purposes regarding sales and tangible personal property through an independent contractor or other representative, if the retailer enters into an agreement with a resident of this state, under which the resident, for a commission or other consideration, directly or indirectly refers potential customers, whether by a link on an Internet website or otherwise, to the retailer.
