

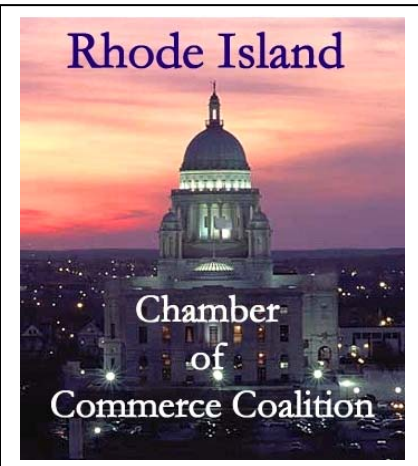

Chamber of Commerce Coalition overview

Background

The Chamber of Commerce Coalition is an expansion of a lobbying partnership that began in 1996. The Coalition was formed as chambers recognized that Rhode Island needed an advocate at the State House to speak for the interests of business. While laws impact both large and small companies, most

business owners and managers don't have time to attend committee hearings and offer testimony on proposed legislation. By having their Chambers of Commerce act as their voice, company officials can easily have a say in the business of government. By unifying chambers throughout the state, the voice of business becomes louder and stronger.

The Chamber Coalition has grown in strength and numbers in the past eight years, expanding to represent thirteen chambers in Rhode Island and more than 12,500 member businesses.

Structure

A Government Affairs Committee, made up of representatives from each of the nine chambers, governs the Chamber of Commerce Coalition. Each chamber has three voting members on the Government Affairs Committee, plus the chief executive of the Chamber. The chair of the committee is Thomas Madden, Esq., Principal, The Madden Law Firm.

The Government Affairs Committee establishes the Legislative Agenda one month prior to the start of each new legislative session, to present for consideration to the respective Chambers of Commerce in the Coalition. The Government Affairs Committee also makes policy recommendations on issues that

are forwarded to the various Chambers for their review. In order to respond quickly to issues, the Government Affairs Committee is fully empowered by the respective Chambers to determine Chamber

positions on issues and take action on them. In the event the Chamber of Commerce Coalition adopts a legislative position that is in conflict with any partner Chamber(s), the Chamber of Commerce Coalition will not testify on behalf of said partner(s) and will note the difference of opinion for the record.

The Chamber of Commerce Coalition works because of the respect that the participating Chambers have for each other, and their needed autonomy. The three lobbyists for the Chamber Coalition are John C. Gregory, President/CEO of the Northern Rhode Island Chamber of Commerce, David R. Carlin, III, Vice President of Government Affairs for the Northern Rhode Island Chamber of Commerce, and Thomas Madden.

The Chamber of Commerce Coalition was active in supporting

- A four-year effort resulting in historic changes to the State Retirement laws, resulting in millions of dollars in savings to the state and municipalities.
- Legislation permitting Health Savings Accounts in Rhode Island.
- The November 2004 voter approved Rhode Island State Constitutional Amendment on Separation of Powers in state government.
- Passage of both Senate bill 3050 -Property Tax Reform legislation, and a measure placed on the November 2006 Ballot, increasing the state's "Rainy Day Reserves" by 1%. (Now a Constitutional Amendment, it mandates the state be allowed to spend only 97% of all revenue it takes in.)
- Passage of legislation increasing the exemption from local excise tax from \$5,000 to \$6,000. The law exempts the first \$6,000 of a vehicle's value from tax.
- Passage of Part I of the Affordable Health Plan and Reinsurance legislation.

- Passage by the House of legislation requiring tangible property is assessed according to a specific, universal and fair classification table.
- Passage of the Biotechnology Investment Tax Credit.

The Chamber of Commerce Coalition was active in helping to prevent

- Legislation that would subject Chamber members to class action lawsuits and duplicate regulation by state agencies.
- Legislation requiring companies contribute 8% of payroll toward health insurance costs or pay a \$250,000 fine to the state, and publicly release highly proprietary financial information.
- Legislation adding a 7% tax to the sale of newspapers and a 7% tax to the advertisements that businesses take out in those newspapers.
- Legislation adding a 1% or 2% assessment to personal income tax.
- “Extension to Sue” legislation
